3. Hazards Identification:

Emergency Overview: A colorless, odorless gas with no warning properties. Non-flammable. Avoid breathing vapors. Wear self-contained breathing or air-supplied respirator. Potential Health Hazards

Skin: Direct contact with the liquefied material or escaping compressed gas may cause frostbite injury. Eyes: Direct contact with the liquefied material, compressed gas, may cause frostbite injury. Inhalation: This product may cause suffocation by displacing the oxygen in air. Exposure to an oxygen deficient atmosphere (less than 19.5%) may cause dizziness, drowsiness, nausea, vomiting, diminished mental alertness, loss of consciousness and death. Ingestion: Not applicable (gas at normal conditions). Delayed Effects: None known. Ingredients found on one of the OSHA designated carcinogen lists are listed below. Ingredient Name: No ingredients listed in this section.

4. First aid measures

Skin: Wash exposed area extremely thoroughly, but gently. In cases of frostbite-like injury, wash with soap and water. Contact a physician if irritation or pain persists.

Eyes: Flush eyes with copious amounts of warm water for at least 15 minutes. Contact a Physician if irritation, pain, swelling, excessive tearing, or photophobia (painful sensitiveness to strong light) persists.

Inhalation: Remove person to fresh air. If not breathing, administer artificial respiration. If breathing is difficult, administer oxygen. Obtain prompt medical attention.

Ingestion: Ingestion is not a likely route of exposure for Octafluoropropane.

Advice to Physician: No specific treatment. Treat according to symptoms present.

7. Handling and Storage

Normal Handling: Always wear recommended personal protective equipment. Observe precautions on cylinder label. Protect cylinders from physical damage.

11. Toxicological Information

LC₅₀ (Inhalation): Simple Asphyxiant; four-hour exposure to 11% Octafluoropropane produced no deaths in rats. Weight gain in female rats was slightly depressed.

LD₅₀ (Oral): Not applicable LD₅₀ (Dermal): Not applicable

Skin Corrosivity: Octafluoropropane is not corrosive to the skin.

Additional Notes: Dogs that were exposed to 30% Octafluoropropane or less did not exhibit cardiac sensitization. Two out of eight dogs that were exposed to 40% Octafluoropropane exhibited some signs of cardiac sensitization.

Octafluoropropane at concentrations of up to 80% was not mutagenic in a bacterial (Salmonella) assay.
